Resolution No. 2023-3107

A Resolution of the City of Sanford, Florida, amending the City's annual operating budget for the fiscal year beginning October 1, 2022 and ending September 30, 2023 to address funds received from the award of a Community Project Funding Grant; providing for implementing administrative actions; providing for a savings provision; providing for conflicts; providing for severability and providing for an effective date.

Whereas, the Commission of the City of Sanford, Florida has adopted an annual operating budget for the fiscal year beginning October 1, 2022 and terminating on September 30, 2023 specifying certain projected revenues and expenditures for the operations of Sanford municipal government; and

Whereas the City's budget presumes that each department generally will, to the best of their ability, maintain its expenditures within its allocated budgeted level and exercise prudence in expending funds during the course of the City's fiscal year; and

Whereas, from time-to-time circumstances and events may require that the original City budget may need revision such as funds received as the result of a Community Project Funding Grant being awarded to the City as a result of actions by former Congresswoman Stephanie Murphy and budgetary amendments are also often associated with the expenditure of the funds received from grants; and

Whereas, the City Commission, in its judgment and discretion, has the authority to adjust the budget to more closely coincide with actual and expected events.

Now, therefore, be it adopted and resolved by the City Commission of the City of Sanford; Florida as follows:

Section 1. Adoption of Budget Amendment; Community Project Funding Grant; Procurement Of Barricades.

(a). The annual operating budget of the City of Sanford for the fiscal year beginning October 1, 2022 and terminating on September 30, 2023 is hereby revised and amended by Attachment "A" pertaining to funds received by the City relating to a Community Project Funding Grant awarded to the City by the United States Government. The Attachment is hereby incorporated into this Resolution as if fully set forth herein verbatim. Except as amended herein, the annual operating budget for the City of Sanford for fiscal year beginning October 1, 2022 and terminating on September 30, 2023 shall remain in full force and effect.

(b). The City Commission also approves the procurement of the barricades that will be purchased from MERIDIAN® Rapid Defense Group utilizing General Service Administration (GSA) contract #47QSWA19D001F and the Community Project Funding Grant funding.

Section 2. Implementing administrative actions.

The City Manager, or designee, is hereby authorized and directed to implement the provisions of this Resolution by means of such administrative actions as may be deemed necessary and appropriate as well as the use of the Community Project Funding Grant funding and the procurement of barricades from MERIDIAN® Rapid Defense Group.

Section 3. Savings.

The prior actions of the City of Sanford relating to the adoption of the City budget and related activities are hereby ratified and affirmed.

Section 4. Conflicts.

All resolutions or parts of resolutions in conflict with this Resolution are hereby repealed.

Section 5. Severability.


If any section, sentence, phrase, word, or portion of this Resolution is determined to be invalid, unlawful or unconstitutional, said determination shall not be held to invalidate or impair the validity, force or effect of any other section, sentence, phrase, word, or portion of this Resolution not otherwise determined to be invalid, unlawful, or unconstitutional.

Section 6. Effective Date.

This Resolution shall become effective immediately upon enactment.





SYNOPSIS:

Approval of Resolution No. 3107, to amend the budget and approval of a Community Project Funding Grant in the amount of \$99,000 to purchase barricades from MERIDIAN Rapid Defense Group utilizing GSA contract #47QSWA19D001F, is requested.

FISCAL/STAFFING STATEMENT:

The Community Project Funding Grant in the amount of \$99,000 would be paid on a reimbursement basis for the procurement of barricades. This funding would provide for enhanced law enforcement for the citizens without the use of City tax dollars. The piggyback procurement process saves the City the costs of administrative time and other activities in the procurement process. The quote from the vendor for the barricades is in the amount of \$94,789.34.

BACKGROUND:

In April, 2022 the Police Chief applied for former Congresswoman Stephanie Murphy's Community Project Funding Grant. The application was for the funding of barricades that can easily be deployed and un-deployed and stored with minimal space. Having the barricades available as a resource would allow the Police Department to secure areas safely without the use of law enforcement vehicles or personnel to block roadways or in other appropriate tactical ways. The City was awarded the sum \$99,000 on a reimbursement basis for the procurement of the barricades that will be purchased from MERIDIAN® Rapid Defense Group utilizing General Service Administration (GSA) contract #47QSWA19D001F.

MERIDIAN® is headquartered in Pasadena, California, and operates in the United States, Europe, Asia and Australia as perimeter security specialists. MERIDIAN® develops anti-vehicle barrier systems that are engineered for speed of deployment, requiring no electricity, hydraulics assembly

maintenance or parts. MERIDIAN® products are certified for the safety features and are used by law enforcement, professional sports, colleges and universities, large events and venues, hospitals, farmers' markets and more. The barricades are a anti-terrorism tool that is being used internationally.

The City's Purchasing Policy requires City Commission approval when a procurement exceeds \$50,000 for a single vendor in a fiscal year. The piggybacking of a GSA contract is authorized by the City's Purchasing Policy and saves the City considerable staff time and associated costs. The quote for the barricades is in the amount of \$94,789.34.

The GSA is an independent agency of the United States government established in 1949 to help manage and support the basic functioning of Federal agencies and engages in a wide array of procurement activities designed to obtain the best costs available for goods and services.

LEGAL REVIEW:

The Assistant City Attorney has reviewed this matter and has no legal objection to the actions. This action will be implemented by the drafting of a piggyback contract with MERIDIAN®.

RECOMMENDATION:

City staff recommends approval of Resolution No. 3107 and the approval of the receipt of the Community Project Funding Grant in the amount of \$99,000, the purchase from MERIDIAN®.
