A Resolution of the City of Sanford, Florida, amending the City's annual operating budget for the fiscal year beginning October 1, 2022 and ending September 30, 2023 for procurements to replace equipment and structures and other materials at City parks due to high winds and debris and due to high flood waters due to for providing implementing Hurricane lan: administrative actions: providing for savings а providing for conflicts; providing for provision: severability and providing for an effective date.

Whereas, the City Commission of the City of Sanford, Florida has adopted an annual operating budget for the fiscal year beginning October 1, 2022 and terminating on September 30, 2023 specifying certain projected revenues and expenditures for the operations of Sanford municipal government; and

Whereas, the City's budget presumes that each department generally will, to the best of their ability, maintain its expenditures within its allocated budgeted level and exercise prudence in expending funds during the course of the City's fiscal year; and

Whereas, from time-to-time circumstances and events may require that the original City budget may need revision such as for procurements to replace equipment and structures and other materials at City parks due to high winds and debris and due to high flood waters due to Hurricane lan; and

Whereas, the City Commission, in its judgment and discretion, has the authority to adjust the budget to more closely coincide with actual and expected events.

Now, therefore, be it adopted and resolved by the City Commission of the City of Sanford, Florida as follows:

# Section 1. Adoption of Budget Amendment; Procurements Resulting from Hurricane Ian.

The annual operating budget of the City of Sanford for the fiscal year beginning October 1, 2022 and terminating on September 30, 2023 is hereby revised and amended by Attachment "A" for procurements to replace equipment and structures and other materials at City parks due to high winds and debris and due to high flood waters due to Hurricane Ian. The Attachment is hereby incorporated into this Resolution as if fully set forth herein verbatim. Except as amended herein, the annual operating budget for the City of Sanford for fiscal year beginning October 1, 2022 and terminating on September 30, 2023 shall remain in full force and effect.

#### Section 2. Implementing administrative actions.

The City Manager, or designee, is hereby authorized and directed to implement the provisions of this Resolution by means of such administrative actions as may be deemed necessary and appropriate in order to implement the procurements to replace equipment and structures and other materials at City parks due to high winds and debris and due to high flood waters due to Hurricane Ian.

#### Section 3. Savings.

The prior actions of the City of Sanford relating to the adoption of the City budget and related activities are hereby ratified and affirmed including, but not limited to, those pertaining to the City's addressing the impacts of Hurricane Ian.

#### Section 4. Conflicts.

All resolutions or parts of resolutions in conflict with this Resolution are hereby repealed.

#### Section 5. Severability.

If any section, sentence, phrase, word, or portion of this Resolution is determined to be invalid, unlawful or unconstitutional, said determination shall not be held to invalidate or impair the validity, force or effect of any other section, sentence, phrase, word, or portion of this Resolution not otherwise determined to be invalid, unlawful, or unconstitutional.

#### Section 6. Effective Date.

This Resolution shall become effective immediately upon enactment.

#### SYNOPSIS:

Approval of Resolution No. 2023-3148, amending the City budget and the approval to procure equipment and services due to Hurricane Ian 2022 are requested.

#### FISCAL/STAFFING STATEMENT:

Funds in the amount of, \$115,078 are requested and available in the General Reserve Fund.

#### **BACKGROUND:**

Below is the itemized list of services and requests.

Replace two benches on Riverwalk – Keystone Ridge	\$5,165
Replace Swing and Safety Surface at James Dunn Park – Game Time	\$55,921
Replace landscaping along Riverwalk – Hibernia LLC	\$3,910
Install sod on Riverwalk – Lake Gem Farms	\$19,152
Replace McKibbin Park Canvas Top – Shade Systems	\$30,930

Staff will be using the procurements to replace two benches that were damaged due to fallen trees, replace a damaged swing and safety surface at James Dunn Park due to a fallen tree and replace the canvas top of the shade structure at McKibbin Park due to high winds and debris from Hurricane Ian. The other services would be for landscaping material and additional sod along Riverwalk that were destroyed due to high flood waters due to Hurricane Ian.

The purchase of the landscape, sod and swings were completed through a competitive bid and the canvas top and benches will be purchased through the manufacturer of those products due to them being proprietary to the manufacture of those items.

The adoption of a budget amendment resolution and authorization to procure services are requested. The services will be procured in accordance with the City's Purchasing Policies and Procedures.

#### **LEGAL REVIEW:**

The Assistant City Attorney has assisted in this matter and has no legal objection.

#### **RECOMMENDATION:**

City staff recommends that the City Commission approve Resolution No. 2023-3148, to amend the budget and approve the procurement of services to various vendors in various park locations, in an amount not to exceed \$115,078.
