#### Resolution No. 3150

A Resolution of the City of Sanford, Florida, amending the City's annual operating budget for the fiscal year beginning October 1, 2022 and ending September 30, 2023; providing for implementing administrative actions; providing for a savings provision; providing for conflicts; providing for severability and providing for an effective date.

Whereas, the Commission of the City of Sanford, Florida has adopted an annual operating budget for the fiscal year beginning October 1, 2022 and terminating on September 30, 2023 specifying certain projected revenues and expenditures for the operations of Sanford municipal government; and

Whereas, the City's budget presumes that each department generally will, to the best of their ability, maintain its expenditures within its allocated budgeted level and exercise prudence in expending funds during the course of the City's fiscal year; and

Whereas, from time-to-time circumstances and events may require that the original City budget may need revision; and

Whereas, the City Commission, in its judgment and discretion, has the authority to adjust the budget to more closely coincide with actual and expected events.

Now, therefore, be it adopted and resolved by the City Commission of the City of Sanford, Florida as follows:

### **Section 1. Adoption of Budget Amendment.**

The annual operating budget of the City of Sanford for the fiscal year beginning October 1, 2022 and terminating on September 30, 2023 is hereby revised and amended by Attachment "A". The Attachment is hereby incorporated into this Resolution as if fully set forth herein verbatim. Except as amended herein, the annual operating budget for the City of Sanford for fiscal year beginning October 1, 2022 and

terminating on September 30, 2023 shall remain in full force and effect.

### Section 2. Implementing administrative actions.

The City Manager, or designee, is hereby authorized and directed to implement the provisions of this Resolution by means of such administrative actions as may be deemed necessary and appropriate.

### Section 3. Savings.

The prior actions of the City of Sanford relating to the adoption of the City budget and related activities are hereby ratified and affirmed.

### Section 4. Conflicts.

All resolutions or parts of resolutions in conflict with this Resolution are hereby repealed.

### Section 5. Severability.

If any section, sentence, phrase, word, or portion of this Resolution is determined to be invalid, unlawful or unconstitutional, said determination shall not be held to invalidate or impair the validity, force or effect of any other section, sentence, phrase, word, or portion of this Resolution not otherwise determined to be invalid, unlawful, or unconstitutional.

### Section 6. Effective Date.


This Resolution shall become effective immediately upon enactment.



### SYNOPSIS:

Approval of Resolution No. 3150, amending the budget and procurements for the full depth asphalt rehabilitation in the Dreamwold sub-division is requested.

### FISCAL/STAFFING STATEMENT:

Funding in an amount of \$1,700,000 is requested and available from the 9<sup>th</sup> Cent Fuel Tax Fund.

#### **BACKGROUND:**

The Dreamwold subdivision is in need of a Full Depth Asphalt Reclamation. Over the last 50 years, layers of asphalt were placed on top of one another affecting the road structure to the base resulting in the roadways integrity and inability to properly drain stormwater runoff. Funding for the project will come from the City's share of the 9<sup>th</sup> Cent Fuel Tax Fund. Procurements totaling in an amount not to exceed \$1,700,000 is requested for the following competitively bid solicitations:

- (1.) Execute a Piggyback contract to Asphalt Paving Systems, Inc. of Zephyrhills, FL contract with City of Kissimmee IFB 2022-002 awarded on June 21, 2022 and expires on September 20, 2025 in an amount of \$975,000 for Full Depth Road Base Reclamation.
- (2.) \$550,000 for In-Place Asphalt Services to The Middlesex Paving, LLC arising from piggyback (PBA 19/20-53) of Seminole County Contract bid number IFB-603616-19/BJC for Pavement Management Services. Seminole County's agreement executed on December 26, 2019. The agreement is currently on its 4th year of the agreement.
- (3.) \$175,000 to Caraway Concrete Construction (IFB 21/22-29) for concrete services.

#### **LEGAL REVIEW:**

The City attorney has prepared Piggyback Contract PBA 22/23-270 to Asphalt Paving Systems, Inc., Resolution No. 3150, and reviewed the documents associated with this project and has no objections as it follows the City of Sanford's purchasing policies.

### **RECOMMENDATION:**

City staff recommends that the City Commission approve the Resolution No. 3150, in an amount not to exceed \$1,700,000 for the following: \$975,000 to Asphalt Paving Systems, Inc.; \$550,000 to The Middlesex Paving LLC; and \$175,000 to Caraway Concrete Company, for the Full Depth Asphalt Rehabilitation Project in the Dreamwold Sub-division.
