

Resolution No. 2024-3321

A Resolution of the City of Sanford, Florida, amending the City's annual operating budget for the fiscal year beginning October 1, 2024 and ending September 30, 2025 relating to the amendment to address the Patrick Leahy Bulletproof Vest Partnership Grant Program as administered by the United States Department of Justice, Office of Justice Programs, Bureau of Justice Assistance and related activities; providing for general and specific implementing administrative actions; providing for a savings provision; providing for conflicts; providing for severability and providing for an effective date.

Whereas, the Commission of the City of Sanford, Florida has adopted an annual operating budget for the fiscal year beginning October 1, 2024 and terminating on September 30, 2025 specifying certain projected revenues and expenditures for the operations of Sanford municipal government; and

Whereas, the City's budget provides for certain methodologies and criteria for the expenditure of budgeted funds during the course of the City's fiscal year; and

Whereas, from time-to-time circumstances and events may require that the original City budget and implementing provisions may need revision such as to address the Patrick Leahy Bulletproof Vest Partnership Grant Program as administered by the United States Department of Justice, Office of Justice Programs, Bureau of Justice Assistance and related activities; and

Whereas, the City Commission, in its judgment and discretion, has the authority to adjust the budget to more closely coincide with actual and expected events and the sound implementation of the projects and programs of the City such as the Patrick Leahy Bulletproof Vest Partnership Grant Program as administered by the United States Department of Justice, Office of Justice Programs, Bureau of Justice Assistance and

related activities,

Now, therefore, be it adopted and resolved by the City Commission of the City of Sanford, Florida as follows:

Section 1. Adoption Of Budget Amendment; Patrick Leahy Bulletproof Vest Partnership Grant Program; Administered By The United States Department Of Justice, Office Of Justice Programs, Bureau Of Justice Assistance; Related Activities.

The annual operating budget of the City of Sanford for the fiscal year beginning October 1, 2024 and terminating on September 30, 2025 is hereby revised and amended to address the Patrick Leahy Bulletproof Vest Partnership Grant Program as administered by the United States Department of Justice, Office of Justice Programs, Bureau of Justice Assistance and related activities, as set forth in the Exhibit to this Resolution. Except as amended herein, the annual operating budget for the City of Sanford for fiscal year beginning October 1, 2024 and terminating on September 30, 2025 shall remain in full force and effect.

Section 2. Implementing Administrative Actions; Procurement of Goods And Services; Patrick Leahy Bulletproof Vest Partnership Grant Program; Related Activities.

The City Manager, or designee, is hereby authorized and directed to implement the provisions of this Resolution by means of such administrative actions as may be deemed necessary and appropriate with regard to the provisions of this Resolution. Notwithstanding the generality of the foregoing, the City Manager, or designee(s), shall have authority to implement the procurement of goods and services to address the Patrick Leahy Bulletproof Vest Partnership Grant Program. Such activities shall be implemented in accordance with the Purchasing Policies and Procedures of the City

and controlling State law.

Section 3. Savings.

The prior actions of the City of Sanford relating to the adoption of the City budget and related procurement activities are hereby ratified and affirmed.

Section 4. Conflicts.

All resolutions or parts of resolutions in conflict with this Resolution are hereby repealed.

Section 5. Severability.

If any section, sentence, phrase, word, or portion of this Resolution is determined to be invalid, unlawful or unconstitutional, said determination shall not be held to invalidate or impair the validity, force or effect of any other section, sentence, phrase, word, or portion of this Resolution not otherwise determined to be invalid, unlawful, or unconstitutional.

Section 6. Effective Date.


This Resolution shall become effective immediately upon adoption.







SYNOPSIS:

Approve Resolution No. 2024-3321, to amend the Police Department budget, in the amount of \$18,222 and approve the Patrick Leahy Bulletproof Vest Partnership Grant is requested.

FISCAL/STAFFING STATEMENT:

Required matching funds will be budgeted by means of the proposed budget amendment adopted by the approval of Resolution No. 2024-3321 in the amount of \$18,222.

BACKGROUND:

The Patrick Leahy Bulletproof Vest Partnership Grant Program reimburses states, units of local government, and federally recognized Indian tribes, for up to 50% of the cost of body armor vests purchased for law enforcement officers. The Program is administered by the United States Department of Justice, Office of Justice Programs, Bureau of Justice Assistance.

Since 1999, over 13,000 jurisdictions have participated in the Program, with a total of \$573 million in Federal funds for the purchase of over 1.5 million body armor vests. One study shows that, since 2015, body armor vests were directly attributable to saving the lives of at least 305 law enforcement and corrections officers and 43 of those body armor vests were purchased, in part, with Program funds.

The City’s Police Department is committed to deploying its personnel in a manner that provides for maximum safety in dangerous situations. The deployment of bullet proof vests contributes, to a significant extent, to that goal.

LEGAL REVIEW:

The Assistant City Attorney has assisted in this matter and has no legal objection to the proposed actions.

RECOMMENDATION:

City staff recommend that the City Commission approve Resolution No. 2024-3321, to amend the Police Department budget in the amount of \$18,222 and approve the Patrick Leahy Bulletproof Vest Partnership Grant.
