The City Manager Monthly Report has been produced almost every month for the last year. This report allowed Departments to capture monthly accomplishments and provide updates on various projects and initiatives throughout the City. In efforts to streamline communication with the Community, staff reviewed and revised the report based on City Commission feedback.

This new reporting format and style will make information more easily digestible for citizens in every district. Commissioners will be able to confidently direct their constituents to the appropriate departments and clearly demonstrate the work staff are doing. The information presented may vary from month to month, and while some departments may showcase more data than others at times, this doesn't mean work isn't being done. The "Highlights" section showcases not only what each department is currently doing, but also events throughout the month they are proud to share. The staff wanted to present not just analytical data, but meaningful insights that reflect the impact and pride behind the work being done citywide.

The City Manager invites the Community to use this report as way to find out what each Department does to keep supporting the City and all who live, work and play here.

City Projects

Golf Course Clubhouse Update

Estimated completion November 2025.

Marina Update

Discussions being conducted with FEMA, no additional updates for this months reporting period.

Fire Station 40

Underground infrastructure (storm structures & piping) along with the water line supplying the fire hydrant are completed. The entrances off Skyway Drive have been cut and the permit for the Marquette entrance was received on May 14th. Underground electrical, plumbing, and HVAC are all installed and all the building footers have been poured. All the exterior masonry walls are set and the interior walls and remainder of the beams, columns, and rakes are expected to be completed the first week June. The project is approximately 25% complete.

Opportunity Site Update

No updates for this months reporting period.

Seminole County Building Discussions

No updates for this months reporting period.

Georgetown Stormwater Basin Update

Georgetown Phase 1A will be completed by December 2026. Phase 2 (final phase) to be completed by the end of 2030 assuming there are no funding problems.

Water Meter Replacement Update

Approximately 95% of the meters should be replaced by August 2025. Due to the difficulty of installation for the remaining 5%, final completion will be November 2025.

Vacuum Sewer Conversion

Completion is scheduled for May 30th for Brewlando and June 13th for Willow Tree (assuming no more FPL delays).

Current state of the north sewage treatment plant and an action plan for repairs or upgrades.

The last Consent Order item must be completed by July 31, 2025. Additional improvements are ongoing with many of the major improvements being completed within 2-3 years.

Building and Successfully Launching the 1:4 Dioxane, and PFAS Treatment Facility Update

1	The City of Sanford has launched an exciting new quarterly e-newsletter, *The Clockwork Chronicle*, and it's already off to a fantastic start! On its very first day, the newsletter gained over 250 subscriptions, highlighting how eager residents are for fresh and engaging ways to stay connected. This new initiative promises to be a great way to keep the community informed and involved.
2	The communications team attended the FMCA (Florida Municipal Communicators Association) conference in Cocoa Beach. FMCA is a professional network for individuals who lead and support communications efforts in Florida's cities, towns, and villages. It provides opportunities for professionals to learn, collaborate, and create innovative solutions for the communities they serve. The City of Sanford brought home two prestigious awards! They earned a Certificate of Excellence in Government Communication and were named the winner for Best Brand Book or Style Guide.
3	The communications team has shifted to highlighting city events and achievements using reels and videos instead of static graphics. This change boosted views on social channels from 21,841 to an impressive 129,939! These engaging visuals have significantly increased the impact and kept more citizens informed about what's happening in the city.
4	The city proudly hosted a vibrant sculpture walk featuring 10 stunning new sculptures crafted by the talented Greg and Alex Mendez, perfectly timed to complement the St. Johns River Festival of the Arts. To enhance the experience, our skilled Digital Media Specialist designed an engaging brochure to guide visitors through this artistic journey! The sculpture walk was
5	The Communications team has relaunched the social media ambassador program and is now collaborating with three community members who specialize in social media. This initiative aims to create a more positive and engaging presence across our channels. By working closely with the community, we're not only demonstrating that the city values public input but also showing we're actively listening to their concerns.

Community Relations *(A City Manager Division)*

1	Richard Moore, an 8th-grade My Brother's Keeper (MBK) student, was awarded a two-year paid scholarship through the "Take Stock" program. This remarkable achievement ensures that Richard will attend any Florida College or University for his first two years without any financial burden. This scholarship underscores the value of investing in our youth, fostering educational attainment, and breaking cycles of poverty by opening pathways to higher education.
2	My Brother's Keeper (MBK) students participated in the Unity Youth Association's (UYA) Mother/Son Dance, a formal evening where young men expressed their gratitude and appreciation for their mothers. This event fostered strong family bonds, encouraged emotional expression, and highlighted the importance of respect and gratitude within familial relationships.
3	The City of Sanford has been allocated \$437,753 in Community Development Block Grant (CDBG) funding for FY 2025/26, reflecting a decrease from the previous allocation of \$464,255. While the reduced funding presents challenges, the City remains committed to prioritizing impactful projects that address community needs.
4	The Race, Equality, Equity, and Inclusion (REEI), in partnership with the Mayor's Youth Council (MYA), hosted two Sanford Speaks community dialogues centered on youth perspectives. These sessions provided a platform for young people to share their understanding of diversity, equity, and inclusion (DEI), communicate key messages they wish adults to hear, and articulate their vision for the future they aspire to create. By engaging directly with our youth, these dialogues foster intergenerational communication, amplify young voices in shaping DEI initiatives, and cultivate a shared vision for a more inclusive community.
5	The Low-Income Home Energy Assistance Program (LIHEAP) staff is now utilizing a new statewide software platform, Promise, to enhance client service and operational efficiency. This innovative software streamlines application management, reduces response times, and provides a more user-friendly experience for residents seeking assistance.

3	Modernization processes were completed for a Communications Office service request form and are in testing for a public art workflow, and Mayors Youth Council workflow.
4	Modernization processes were completed for a City budget survey workflow and are in progress for a purchasing order migration, contracts migration, and Certificate of Insurance migration. Currently testing requisition checklist workflow, a budget transfer workflow, and a budget amendment workflow.
5	Modernization processes also underway for a HR calendar training workflow and an employee onboarding workflow, a special event permit application workflow, golf cart registration workflow, police memo workflow, police endorsement workflow, police leave request workflow, police timesheet workflow, police training request workflow, police equipment request workflow, and a commercial utility request workflow.

Utilities

1	Cathcart Construction continues sewer connection replacement on previously lined gravity sewers for 32 sewer customers in the Mayfair subdivision. The City is coordinating with the property owners to obtain the rights of access agreements to complete this work.
2	The City's staff are repairing fire hydrants that have been placed "out of service". A contract was received from R&M Solutions for hydrants heavy repairs and maintenance. Commission has approved this work directive, and the process will begin once a Purchase Order (PO) is received. Currently, the PO is in the reviewing stage at the City's Purchasing Management.
3	Plans are being reviewed by city staff for water line improvement in the Goldsboro community. This project will have new fire hydrants and improve the water pressure throughout the Goldsboro community.
4	Inliner Solutions (vendor) has cleaned and started lining manholes. In the next few weeks, Inliner Solutions will prepare to mobilize and begin installation of the liner inside the gravity mainlines on the eastside of the City.
5	VEPO (vendor) has installed 19,000 residential/commercial water meters to date which is approximately 75% of existing meters. Large commercial meters will ramp-up change out in the near future.
6	Prepared all portable generators for hurricane season.
7	Finished the electrical set-up for the North Water Reclamation Facility Master Lift Station.
8	Installed diesel pump at the 9th & Cypress Lift Station.
9	Wrote a Standard Operating Procedure for the South Water Resource Center generator start-up
10	Poured Odor Control unit cement pad at the North Water Reclamation Facility.

Parks & Recreation

Parks

1	Sanford's commitment to beautification shines through its recent Palm Tree Project along Seminole Boulevard, where 168 palms were carefully pruned to enhance the city's scenic gateway to the Riverwalk. Led by the Parks Division with support from local arborists, the project was thoughtfully executed to minimize disruption while maximizing visual appeal. The refreshed palm-lined corridor now offers a welcoming, picturesque route for residents and visitors alike, reflecting Sanford's charm and its growing reputation as a hub for festivals, events, and community gatherings.
2	The City of Sanford Parks Division has expanded its fleet with a new 8-yard garbage truck, enhancing efficiency and cleanliness as the city grows as a destination for festivals, special events, and Riverwalk activities. Designed to handle larger loads and navigate event spaces smoothly, the truck streamlines waste collection, reducing trips, fuel consumption, and environmental impact. This investment ensures Sanford remains clean and welcoming for residents and visitors alike. Acquired for \$137,919, the truck was funded by the City and is expected to be reimbursed through TrailGo, a new grant from the Florida Department of Environmental Protection.
3	As the rainy season approaches, Sanford's Parks Operations team has cleared storm drains at Lee P. Moore Park to prevent flooding and protect this popular community space. Storm drains, often clogged with debris over time, are vital for managing heavy summer rains and hurricane impacts. This proactive maintenance helps keep walkways, playgrounds, and green spaces safe and accessible, reflecting the City's broader commitment to storm readiness and environmental stewardship across all its parks.

4	The City of Sanford Parks Division is proactively addressing shoreline erosion along the Riverwalk, where around 80 washout holes near the seawall were identified. Crews quickly secured the areas and began repairs to prevent safety hazards, preserve the seawall's integrity, and maintain the Riverwalk's beauty. This effort reflects Sanford's ongoing commitment to public safety, cost-effective maintenance, and the long-term care of one of its most beloved community spaces.

Recreation & Museum

1	Westside Mentoring continues to provide ongoing mental health sessions for students and parents through a partnership with SISTAS (Sistas Inspiring Sisters to Achieve Success Inc.) organization and Educating the Whole Child, Inc.
2	The Larry A. Dale Aquatic Center was proud to host the Florida High School Athletic Association District 2 and Region 1 Championship Water Polo Tournaments. High school water polo teams from across the state participated in the events. Both the boys' and girls' teams from Seminole High School secured the regional championship titles and went on to compete in the state championships in Miami.
3	Historic Sanford Memorial Stadium hosted college baseball games between the Florida A&M University Rattlers and the Bethune-Cookman University Wildcats. The two teams were tied for the Southwestern Athletic Conference lead with identical 13 & 2 conference records. The games were played on Thursday, April 17th, Friday, April 18th, and Saturday, April 19th, with BCU taking the series and the conference lead.
4	City of Sanford Parks & Recreation & Ladies 327 played host to the annual Easter EGGstravaganza, Saturday, April 19th, from 9 AM until NOON at the Jeff Triplett Community Center. Egg hunts were held in four separate age groups, with first, second, and third place baskets going to the winners. Over 1000 children and their families attended this free family event.
