- The first Billboard is located on US 17/92, about ½ mile from Lake Mary Boulevard with weekly impressions for ages 18+ being 63,746. It is less than a mile from the Seminole State College and is across from the Seminole County Courthouse. The billboard size is 10'6" x 36'.
- The second billboard is on I-4 in Volusia County just south of Deland exit 44. The billboard size is 14' x 48' and ages 18+ weekly impressions are 99,464.
- The third billboard is on I-4 westbound heading to downtown Orlando near the maitland exchange. The billboard size is 14' x 48' and the ages 18+ weekly impressions are 192,165.

Event Regulations

- Spaces are available on a first-come, first-served basis. Sub-leasing of sponsor spaces is prohibited without prior authorization. Sponsor placement will be determined by City staff.
- No fireworks, sparklers or other explosive devices are to be sold or handed out. No flea market, resale or carnival type items.
- No food, water or beverage sales are allowed to be sold from your booth, including free water or food samples.
- Sponsor displays must stay in the designated space. This includes display racks, tables, etc. Sponsors may not stroll event area without additional authorization and specific "Strolling Vendor" permit and issued Badges.
- Sponsor understands the Celebration will occur rain or shine and the City of Sanford is not responsible for any reimbursements of losses due to inclement weather.
- Set-up begins at 4 PM. Vehicles must be removed by 5 PM. Booths must be set up and staffed from 6 –10 PM.
- Sponsors may not demonstrate in any manner their reason for existence other than by displaying the name of the group or organization and/or providing samples of literature about their organization, product(s) and/or service(s).
- Break-down/strike may not occur prior to fireworks finale. Cars will not be allowed in the event area until after the fireworks and the roads are clear of pedestrian traffic.
- All garbage, products & equipment must be removed from allocated space at the end of the event. The rental space must be in the same condition as when Sponsor assumed occupancy.
- Sponsors grant full permission to the City of Sanford and/or their authorized agents to use any photographs, videotapes, recordings, or any other record on this event for any legitimate purpose.

Hold Harmless & Signature

By signing this application, I hereby agree to abide by the terms and conditions as defined above. I also agree to Indemnify, Hold Harmless and Defend the City of Sanford, its elected and appointed officials, employees, agents and volunteers, and their heirs, representatives, successors, executors, administrators and assigns from and against any and all suits and actions including attorneys fees and all costs of litigation and judgments, claims for damages or injuries, including death, to persons or property of whatever kind or character, whether real, personal or mixed, asserted or occurring from every name and description arising out of or incidental to the 4th of July Celebration whether or not due to or caused by the negligence of the City of Sanford, excluding only the sole negligence of the City of Sanford. This provision shall also pertain to any claims against the City of Sanford by any employee or volunteer of Sponsor or anyone directly or indirectly employed by Sponsor. I agree that this is a binding agreement that is intended to be as broad and inclusive as allowed and shall be governed by, construed and enforced in accordance with the laws of the State of Florida.
