

Resolution No. 2025-3439

A Resolution of the City of Sanford, Florida, amending the City's annual operating budget for the fiscal year beginning October 1, 2025 and ending September 30, 2026; providing for implementing administrative actions; providing for a savings provision; providing for conflicts; providing for severability and providing for an effective date.

Whereas, the Commission of the City of Sanford, Florida has adopted an annual operating budget for the fiscal year beginning October 1, 2024 and terminating on September 30, 2025 specifying certain projected revenues and expenditures for the operations of Sanford municipal government; and

Whereas, the City's budget presumes that each department generally will, to the best of their ability, maintain its expenditures within its allocated budgeted level and exercise prudence in expending funds during the course of the City's fiscal year; and

Whereas, from time-to-time circumstances and events may require that the original City budget may need revision; and

Whereas, the City Commission, in its judgment and discretion, has the authority to adjust the budget to more closely coincide with actual and expected events.

Now, therefore, be it adopted and resolved by the City Commission of the City of Sanford, Florida as follows:

Section 1. Adoption of Budget Amendment.

The annual operating budget of the City of Sanford for the fiscal year beginning October 1, 2025 and terminating on September 30, 2026 is hereby revised and amended by Attachment "A". The Attachment is hereby incorporated into this Resolution as if fully set forth herein verbatim. Except as amended herein, the annual operating budget for the City of Sanford for fiscal year beginning October 1, 2025 and

terminating on September 30, 2026 shall remain in full force and effect.

Section 2. Implementing administrative actions.

The City Manager, or designee, is hereby authorized and directed to implement the provisions of this Resolution by means of such administrative actions as may be deemed necessary and appropriate.

Section 3. Savings.

The prior actions of the City of Sanford relating to the adoption of the City budget and related activities are hereby ratified and affirmed.

Section 4. Conflicts.

All resolutions or parts of resolutions in conflict with this Resolution are hereby repealed.

Section 5. Severability.

If any section, sentence, phrase, word, or portion of this Resolution is determined to be invalid, unlawful or unconstitutional, said determination shall not be held to invalidate or impair the validity, force or effect of any other section, sentence, phrase, word, or portion of this Resolution not otherwise determined to be invalid, unlawful, or unconstitutional.

Section 6. Effective Date.

This Resolution shall become effective immediately upon enactment.

SYNOPSIS:

Requesting to approve a budget amendment resolution and associated procurement relating to funds from the Impact Fees account for purchase of the suite of services from PowerDMS by NEOGOV.

FISCAL/STAFFING STATEMENT:

The Police Department will make use of a total of \$21,145.11 from the Impact Fees account to purchase access to the suite of products detailed in the attached quote, offering new and enhanced services to our officers. Along with some current services which have been enhanced by giving us direct access to Seminole County information, we are also incorporating some new services (Professional Standards Suite or PSS) into our purchase.

BACKGROUND:

PowerDMS by NEOGOV is a workforce management platform used by over 5,500 law enforcement, fire, EMS and emergency communications customers. It provides tools for managing, training, and supporting employees across their careers, addressing the challenges faced by public safety organizations. The platform covers policy management, community engagement, staff scheduling and more.

Three new products work together (Professional Standards Suite or PSS) to provide efficiency, accountability and data in one user-friendly suite that helps elevate agency operations. Professional Standards Suite (PSS) is comprised of three solutions uniquely designed for law enforcement and corrections agencies. The solutions work together to elevate officer resilience, agency health, and community safety, ultimately empowering agencies to maintain the highest standards of excellence within a single, easy-to-use platform. The new PSS encompasses three fully integrated pieces of software - Action, IA and Vitals. Together, they provide efficiency, accountability, and invaluable data to inform decision making and strategic planning. All solutions are user-friendly, completely secure, and fully customizable to fit any agency's unique needs.

- PowerAction is streamlined reporting software that helps document, manage, and review officers' on-duty actions like pursuits, use of force, equipment damage, and more. The system includes 15 pre-built template reports that can be used out of the box as standard forms or customized to fit an agency's unique needs.
- PowerIA is secure case management software that helps agencies reliably manage internal affairs cases and complaints from start to finish. Investigators and supervisors can view

case status, priority, and more in the user-friendly dashboard. The system prioritizes case security with easy permission management and detailed audit logs.
